

**CITY OF LAKE BUTLER  
REGULAR MEETING  
JANUARY 13, 2013**

Herndon stated that the FDEP will be in the city on 1/14/2013 regarding the lakeside dock, permits and the lease. She stated that she will address getting repairs at that time.

Motion to approve budget amendments made by Beasley. Second by Jenkins and carried unanimously.

Mecusker advised that this effort is in conjunction with the Union County Tobacco Partnership.
