FIRST PUBLIC HEARING NOTICE

City of Lake Butler

The City of Lake Butler is considering applying to the Florida Department of Economic Opportunity (DEO) for one or more Small Cities Community Development Block Grants (CDBG) for the 2014 CDBG program year. Each grant is expected to not exceed \$650,000. CDBG funds may be used for one of the following purposes: 1. To benefit low and moderate income persons; 2. To aid in the prevention or elimination of slums or blight; or 3. To meet other community development needs of recent origin having a particular urgency because existing conditions pose a serious and immediate threat to the health or welfare of the community and where other financial resources are not available to meet such needs. The categories of activities for which these funds may be used are in the areas of housing, neighborhood revitalization, commercial revitalization, or economic development and include such improvement activities as acquisition of real property, loans to private-for-profit business, purchase of machinery and equipment, construction of infrastructure, planning/design, rehabilitation of houses and commercial buildings, and energy conservation. Additional information regarding the range of activities that may be undertaken will be provided at the public hearing. For each activity that is proposed, at least 70% of the funds must benefit low and moderate income persons. In developing an application for submission to DEO, the City of Lake Butler must plan to minimize displacement of persons as a result of planned CDBG activities. In addition, the City is required to develop a plan to assist displaced persons. A public hearing to receive citizen views concerning the community's economic and community development needs will be held on January 12, 2014 at 5:30 p.m., or as soon thereafter as may be heard at the City of Lake Butler City Hall at 200 SW 1st Street, Lake Butler Florida 32054 . For more information concerning the public hearing contact Ms. Cassa Neta Herndon, Purchasing Director at (386) 496-3401. The public hearing will be conducted in a handicapped accessible location.
